Mr. Evans made a motion to approve the cost of a new jacket, Mr. May seconded the motion. Roll Call Vote: Mr. Stein-Yes, Mr. Evans-Yes, Mr. May - Yes, Ms. Knight -Yes, Mr. McSparran - Yes. The motion passed. The fire department has 17 members presently. Ms. Slagle will reimburse the fire department the cost of the jacket.
