- 2. 8 School Street. The case against the owner is listed on the docket. But a date has not been determined. There is sometimes a log jam at the Prosecutors Office.
- 3. BOPA/Mote & Associate Billing. The BOPA has reviewed two recent bills from Mote and Associates for the Back-Up Generator Project. They do not agree with the Beyond Contract charges for the re-bid of the project. The Board considered the rebid an error on Mote & Associates end and don't think we should be billed for the rebid process, and then with in the charges, they charged for a lift station review, the water plant doesn't have a lift station. The Board also questioned a couple of other items listed within the Beyond Contract charges. Mr. Johnston reviewed the contract and the bills. He noted the contract states all changes need Board approval. There is a Quasi Liability law that says if work is done in good faith, then it may be charged. He suggesting contacting Mote and asking them to review the bill.
